NOTICE IN TERMS OF SECTION 54(1)(f) OF THE NATIONAL ENVIRONMENTAL MANAGEMENT WASTE ACT, ACT NO.59 OF 2008: VARIATION OF THE WASTE MANAGEMENT LICENCE FOR MANGUZI WASTE DISPOSAL SITE.

Notice is hereby given in terms of Section 54(1)(f), read with Section 47 and 73 of the National Environmental Management: Waste Act (Act No. 59 of 2008) as amended (NEM: WA), that uMhlabuyalingana Local Municipality in the Kwazulu Natal Province is conducting a variation of their Waste Management License because it has been reviewed in terms of NEM: WA section 53. The proposed variation entails the amendment of the conditions for Manguzi Waste Disposal Site in terms of Section 54 (2) of NEM: WA. The variation of a waste management license includes-

- a) the attaching of an additional condition or requirement to the waste management license;
- b) the substitution of a condition or requirement;
- c) the removal of a condition or requirement; or
- d) the amendment of a condition or requirement.

PROJECT LOCATION: The Waste disposal facility is located in Ingwavuma Magisterial District on Erf 17497, Tembe North, uMhlabuyalingana Local Municipality under uMkhanyakude District in the Kwazulu Natal Province.

The KwaZulu Natal Province Economic Development, Tourism and Environmental Affairs is the competent authority to vary the Waste Management License. This notice marks the public participation process of **30** days, commencing from date of publication.
