1. Standard Conditions of Quotation:

The following conditions will apply:

- Prices must be valid for at least thirty (30) days from date of your offer.
- Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- **Work must be completed within 3 (three) weeks from date of official order.**

Item No: 1

General Requirements:

- **Width:** 13m (across full carriageway).
- **Height:** 80mm
- **Length (travel direction):** 2.0 m typical for speed humps.
- **Slope:** Smooth transition, max gradient 1:10 to avoid vehicle damage.
- **Material:** Hot Mix Asphalt (HMA), dense-graded, wearing course quality.

Site Preparation:

- **Cleaning:** Remove dust, debris, vegetation, and loose particles.
- **Cutting:** Saw-cut edges of existing asphalt to ensure bonding.
- **Base Check:** Compact existing surface with vibratory roller to achieve firm foundation.
- **Moisture Control:** Ensure dry surface before asphalt placement.

Asphalt Mix Specification:

- **Binder Grade:** Penetration grade bitumen (e.g., 60/70 or PG 64-22 depending on climate).
- **Aggregate Size:** Nominal maximum size 10–14 mm.
- **Mix Temperature:** 135–165°C at laying.
- **Compaction Temperature:** Not less than 90°C.
- **Density Requirement:** Minimum 95% of Marshall design density.

- (b) “**price**” means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

MBD 9 – CERTIFICATE OF INDEPENDENT BID DETERMINATION
