Preference points will be awarded to service providers based on Reconstruction and Development Programme – Government Gazette :16085(1994) initiatives. The bids will remain valid for 90 days. The Council reserves the right to accept all, some, or none of the bids submitted, either wholly or in part and it is not obliged to accept the lowest bid.
