1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Price(s) quoted must be valid from date of appointment until 31 December 2026.
- b) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- c) **The contract will be for a period from date of appointment until 31 December 2026.**
- d) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the **MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.

When the tenderer scoring the highest points cannot perform on the contract, the municipality has the right to purchase from the tenderer

scoring the second highest points and if the second highest points scorer cannot perform on the contract, the municipality reserves the right to purchase from the tenderer scoring the third highest points.

The Theewaterskloof Municipality's objective is to procure reliable and efficient hosting services and ensure the ongoing maintenance, security, and functionality of Theewaterskloof Municipality's website from date of appointment to 31 December 2026, whereafter a three-year tender will be active.

- Service provider must ensure adequate server capacity to accommodate site needs and allow for sufficient future growth.
- Service provider must ensure adequate internet bandwidth transfer capacity and redundant internet backbone capability to allow ease of internet traffic.
- The site must be accessible 24/7 with 99.9% uptime guarantee.
- Email relay routing.
- Domain annual renewal.
- Domain name services (DNS): management of *.twk.gov.za, *.twk.org.za, including email MX records.
- Secure Sockets Layer: *.twk.gov.za SSL integration with wildcard SSL (supply, install, configure, renew).
- Use the current file manager (back end) system for the website.
- The service provider must protect the website from failures, cyber and virus attacks.
- Must ensure optimal performance of the site hosted.
- The service provider must provide a monthly report to the website administrator of Theewaterskloof Municipality. - It should be endeavoured that as much changes as possible be made from the CMS user interface, including the website's current functionality to add/customize and operate online modules and other website enhancements.
- The service provider will maintain daily backups of the web site through the duration of the contract. This to allow for any website data to be available in the event of web server failure. A notification is to be sent to the website administrator each morning to verify the backup. The backup, code and source files will be delivered in full to the municipality on closing of the contract.
- The service provider must have an automated testing system that checks for broken hyperlinks on the site.
- The service provider must verify regularly that the site is up and running and will revert to the back up whenever necessary.
- The contracted service provider must provide formal training in the form of a course and continuously give guidance on using the admin interface of the CMS.

- Monitor the server logs and generate detailed reports (monthly) analysing updated and uploaded information.
- A Service Level Agreement (SLA) is to be provided by the service provider that include all of the above.
- The appointed service provider will be responsible for providing and maintaining all hardware, software and communication (email relay) services needed for full functioning of the website including storage facilities and telecommunication equipment necessary to ensure reliable services.
- The service provider needs to assign a dedicated staff member during office hours for the first 30 days of the contract to assist the client. It will also be required to supply a company organogram, showing the staff capacity.

MBD 9 – CERTIFICATE OF INDEPENDENT BID DETERMINATION
