Quotations will not be accepted if they don't comply with the marking instructions.

Fully completed Quotations must be placed in tender box **No. 2** at the **Main Entrance** of Theewaterskloof Municipality, 6 Plein Street, Caledon by no later than **12:00 on Thursday, 10 September 2026, immediately after which the quotations will be opened, and the opening results will be published, within three (3) days after the closing date, on the Theewaterskloof Municipality's website (www.twk.gov.za)**

1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Price(s) quoted must be valid from 01 October 2026 to 31 December 2026.
- b) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- c) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the **MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.
- d) The successful provider will be the one scoring the highest points.
- e) A **Valid Tax Compliance Status Pin Certificate** and a copy of your **latest Municipal Account / Lease Agreement** must be attached to your quotation subject to the test for administrative compliance.
- f) **The Municipality reserves the right to accept a Quotation in full, partially or not at all and is not obliged to accept the lowest Quotation received.**
- g) Payments will be made not later than 30 days, after the receipt of a tax invoice.
- h) Invoices must not be issued before goods / services have been supplied / rendered.
- i) The General Conditions of Contract will apply to this quotation.
- j) Calculation errors will be corrected by the Municipality by using the unit prices.
- k) If a valid Certified B-BBEE certificate, EME or QSE affidavit is not attached, it will be interpreted that the preference points for B-BBEE status level or contribution are not claimed.
- l) If a valid Certified B-BBEE certificate, EME or QSE affidavit is attached and points are not claimed in terms of the MBD 6.1, it will be interpreted that the preference points for B-BBEE status level or contribution are not claimed.
- m) Please note that the Municipality will not request a valid certified B- BBEE certificate or Sworn Affidavits if such is not attached to the bidder's tender at closing date of this tender.

- n) If the bidder fails to provide proof of a Municipal Account or Lease Agreement in the name of the bidder, where locality points are claimed, it will be interpreted that locality points will not be awarded.
- o) The municipality reserves the right to appoint the bidder scoring first, second and third highest preference points at any time during the duration of the contract. When the tenderer scoring the highest points cannot perform on the contract, the municipality has the right to purchase from the tenderer scoring the second highest points and if the second highest points scorer cannot perform on the contract, the municipality reserves the right to purchase from the tenderer scoring the third highest points.
- p) No alternative offers will be accepted.
- q) **The municipality reserves the right to terminate the contract at any time, as a formal tender process is currently underway.**

2. Bidders' Obligations:

2.1 Eligibility Criteria

Only bidders who satisfy the following criteria are eligible to submit an offer: **(This is a requirement for submission of a bid).**

2.1.1 Pricing Instructions

- To be considered for a contract under this quotation, the bidder must sign and declare compliance with **Schedule 1** and **Schedule 2**.
- Bidders may submit bids for Fibre Services, Wireless Services, or a combination of both service categories. Each service category will be evaluated on its own merits.
- Bidders must price on all the items per schedule of services required and sign to declare compliance. Where no price is charged, bidders must indicate a zero (0) rate and any item left blank or marked with anything other than a written zero rate will be considered incomplete, and the tenderer may be disqualified.

2.1.2 Specifications

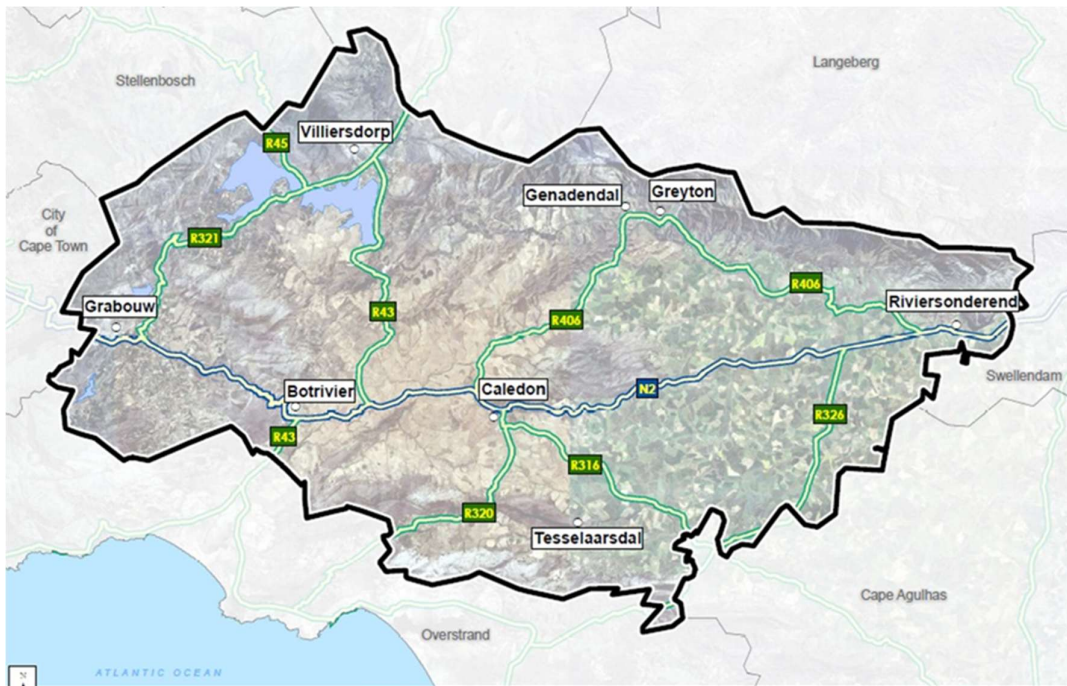

1. SCOPE OF WORKS

The scope of work entails supplying, installing, configuring, and commissioning Internet services to connect seven (7) municipal towns to the Head Office building. This installation aims to ensure uninterrupted Internet connectivity and continuity of municipal operations for a period of three (3) months, pending the finalisation and appointment of a service provider through a formal tender process.

The service provider will be required to install a secure, reliable point-to-point or point-to-multipoint wireless solution, including all necessary equipment such as antennas, radios, mounting brackets, cabling, and power supplies. The solution must provide stable connectivity between the Head Office and the identified towns, with sufficient bandwidth to support essential municipal systems and operational requirements.

The scope also includes configuring network equipment, integrating with the existing municipal network infrastructure, and testing and commissioning all links. The service provider must ensure minimal service disruption during installation and provide basic monitoring, fault response, and technical support for the three-month period.



If the bidder fails to sign this schedule, it will be interpreted that the bidder does not comply with the Scope of works – Wireless Services and therefore will be regarded as being not eligible.

MBD 9 – CERTIFICATE OF INDEPENDENT BID DETERMINATION
