Quotations will not be accepted if they don't comply with the marking instructions.

Fully completed Quotations must be placed in tender box **No. 2** at the **Main Entrance** of Theewaterskloof Municipality, 6 Plein Street, Caledon by no later than **12:00 on Tuesday, 14 July 2026, immediately after which the quotations will be opened, and the opening results will be published, within three (3) days after the closing date, on the Theewaterskloof Municipality's website (www.twk.gov.za)**

1. Standard Conditions of Quotation:

The following conditions will apply:

- a) Prices must be valid for at least ninety (90) days from date of your offer.
- b) Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- c) **The goods must be delivered within one (1) week from date of official order.**
- d) This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the **MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.

- p) The municipality reserves the right to appoint the bidder scoring first, second and third highest preference points at any time during the duration of the contract. When the tenderer scoring the highest points cannot perform on the contract, the municipality has the right to purchase from the tenderer scoring the second highest points and if the second highest points scorer cannot perform on the contract, the municipality reserves the right to purchase from the tenderer scoring the third highest points.

The hiring of plant is required to carry out the suction and disposal of sewage from septic tanks in the Theewaterskloof Municipality.

The Contractor shall be responsible for providing all machinery, equipment, labour and resources required to execute the works.

The Contractor shall comply with all applicable Occupational Health and Safety (OHS) legislation and shall take full responsibility for the safety of employees, the public, equipment and all activities undertaken in connection with this contract.

PROJECT SPECIFICATIONS

Scope

This Project Specification provides a general description of the project, available and required facilities, special contract requirements and the standards to be met by the Contractor.

Status

Should any requirement or provision of this Project Specification conflict with any requirement or provision contained in any other specification, clause or drawing applicable to this contract, the requirements of this Project Specification shall take precedence.

PS1 DESCRIPTION OF THE CONTRACT AND WORKS

The works are funded by and undertaken on behalf of Theewaterskloof Municipality.

PS2 DESCRIPTION OF THE SITE AND ACCESS

PS2.1 Locality

The works will be carried out in:

Villiersdorp
Grabouw
Genadendal / Greyton

The works include:

Septic tank suction services at various locations within Villiersdorp, Grabouw and Genadendal / Greyton. Most sites are readily accessible via existing roads. In certain locations, extension suction hoses or pipes will be required to access septic tanks.

PS2.2 Access to the Site

Existing access roads are available to all work sites.

PS3 Housekeeping

The Contractor shall ensure that all loads are securely covered during loading, transportation and disposal.

The Contractor shall be responsible for immediately cleaning any spillages resulting from improperly secured loads or any activities related to the works.

PS4 Hours of Operation

Unless otherwise instructed by the Employer, the following operating hours shall apply:

Monday to Thursday: 08:00 – 16:30 (excluding public holidays)

Friday: 08:00 – 15:30 (excluding public holidays)

PS5 Plant

The Contractor shall be responsible for the planning, provision and maintenance of all plant and equipment required to execute the works.

The Contractor shall ensure that sufficient operational plant is available at all times to perform the required services in accordance with the Operational Manual.

Any delays resulting from plant breakdowns or equipment failure shall be for the Contractor's account.

PS6 Emergency Services

The Contractor shall be available to respond to emergency call-outs as required by the Employer.

The Contractor shall maintain continuous communication with the Employer's representatives or operators throughout the duration of the contract by means of telephone or radio communication.

1.1 Additional Services

Occupational Health and Safety

In submitting a offer for this contract, the Service Provider acknowledges acceptance of appointment as the Employer's Agent in terms of the Occupational Health and Safety Act, 1993 (Act No. 85 of 1993), and the Construction Regulations, 2014, should the Employer accept the tender.
