- 1.6. The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **tender** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

2. DESCRIPTION

Iziko Museums of South Africa (Iziko) invites service providers to submit quotations for the supply, delivery and assembly of 2 steel library book trolleys, and 200 book ends as per specifications and images below - delivery is to the **Iziko South African National Gallery Annexe (Art Library)**.

The quotation is also for the supply, delivery and installation (assembly) of 3 rows of double-sided library shelving, and 1 row of extra deep single-sided shelves as per the specifications listed below – the shelving is to be installed at the **NH Library situated in the South African Museum**.

3. SCOPE OF WORKS

1. Book trolleys

- 2 x heavy-gauge, powder coated steel trolleys.
- The trolleys must consist of 3 shelves.
- The first 2 shelves are to be double-sided sloping inward shelves.
- The bottom shelf should be a single flat wide-bottom shelf that spans the entire depth of the trolley.
- Dimensions to be 940cm (H) x 940 (W) x 46cm (D)

- 4 heavy-duty caster wheels with a break mechanism attached.



2. Book ends (2 different sizes)

- 100 x steel book ends - 22cm (h) x 15cm (w) x 19,5cm (length)
- 100 x steel book ends - 17cm (h) x 12,5cm (w) x 15cm (length)
- Made of powder coated steel, in colour beige (or similar neutral colour)
- Non-slip base
- If the exact size is not available, it can be upsized by up to 1cm but it cannot be smaller than the specified dimensions.



3. 3 X library shelves with the following dimensions

- Double-sided shelves, with a divider in between separating the two sides
- Height approximately 2metres
- Shelf depths 30 cm, thus the overall width of the shelves should not be less than 60 cm
- Bay sizes of 90cm, with side panels
- Each row to consist of 7 bays thus the rows will be about 6,3 m long.
- Ends and top of the shelves to be fully enclosed (as per image attached)
- Steel construction with a powder coated finish
- Bottom shelf/row must be at least 10cm from the floor
- Images for reference purposes are included below



4. 1 X extra deep library shelf with the following dimensions

- One sided (as the shelf will be against a wall) with a full backing
- Height approximately 2metres (to be the same height as the shelving listed above)
- Shelf length 7 metres, with bay dividers
- Bay size of approximately 1m with side panels
- Shelf depth 60 cm
- Top and sides enclosed

- Steel construction with a powder coated finish
- Bottom shelf/row must be at least 10cm from the floor
