2.2 Have a registered fire extinguisher servicing technician:

a) A registered fire extinguisher servicing technician is a technician registered as such in terms of appropriate competence through training, qualifications, and experience by The South African Qualification & Certification Committee (SAQCC) for Fire.

b) SAQCC for Fire is an industry-elected body, mandated by the DoEL to register individuals working within the sector.

3. The appointed service provider should provide temporary portable fire extinguishers whilst conducting the servicing process.
