The quotation must be in a sealed envelope and clearly marked: **Tender Box No. 2**, for attention, **QUOTATION NO.: MZ 03/2026/27** and the service provider's name and address. Quotations will not be accepted if they don't comply with the marking instructions. Quotations must be placed in tender box **No. 2** at the **Main Entrance** of Theewaterskloof Municipality, 6 Plein Street, Caledon by no later than **12:00** on **Monday, 28 September 2026**, immediately after which the quotations will be opened, and the opening results will be published within 3 days after the closing date on the Theewaterskloof Municipality's website. 1. Standard Conditions of Quotation:

The following conditions will apply:

- Prices must be valid for at least sixty (60) days from the date of your offer.
- Price(s) quoted must be firm and must be inclusive of VAT, clearly indicating Price, VAT and Total Price.
- **The machinery must be delivered within one (1) weeks from date of official order.**
- This quotation will be evaluated in terms of the 80/20 preference point system as prescribed in the Preferential Procurement Regulations of 2022 and for this purpose the **MBD 2, MBD 4, MBD 6.1, MBD 8 & MBD 9** forms which are available on the Municipal Website www.twk.gov.za must be completed and submitted together with your quotation subject to the test for administrative compliance.

- Invoices must not be issued before goods / services have been supplied / rendered.
- Calculation errors will be corrected by the Municipality by using the unit prices.

SCHEDULE 2: SPECIAL CONDITIONS OF CONTRACT

1. DELIVERY TIME

The Contractor will be given an official order for the exact number of hrs. required of the plant required in advance and the contractor must deliver the required plant within 1 week from date of order to the site. If the Contractor cannot deliver the plant within specified time or cannot deliver at all, the municipality must be notified immediately in writing upon receipt of official order stating reason/s for non-delivery and the municipality will decide whether reason/s is valid or not.

2.1 BREAKAGES

In the event of a breakdown, a mechanic must be on site within 6 hours or the plant must be replaced within 8 hours immediately thereafter at the supplier's cost.

2.2 FUEL SHORTAGES

It is expected by the supplier in cases of fuel shortage that sufficient fuel is available at all times. No standing time for such cases shall be claimed.

2. DELIVERY ACCEPTANCE

No deliveries of plant will be acknowledged for which the Contractor cannot produce a logbook.

Contractor must off-load Plant themselves and must wear and use protective clothing and equipment when doing so. All necessary resources must be accompanied when off-loading occurs.

Address of delivery unless otherwise stated is in Grabouw.

3. STANDING TIME

Tenderer will be liable for all costs that the municipality will be held liable for with reference to standing time.

4. PRICE ALL INCLUSIVE

The prices tendered must price an all-inclusive for all costs involved.

5. INSURANCE CLAIMS, ETC.

The Municipality shall not be liable in respect of any claims, damage, accidents, etc. to persons, properties, vehicles, rights, etc., which may arise from the carrying out of this contract.

The Contractor shall insure all laborers, drivers and all plant involved in the fulfillment of this contract and shall indemnify the Municipality against all risks and claims.

6. PAYMENTS

Payments will be made to the Contractor no later than 30 days after receiving of tax invoice for work done up to date.

The invoice rendered to the Municipality shall be checked in comparison with the duplicate of the logbook and no payment whatsoever shall be made in respect of any plant on the account unless the amount for hours has been verified in this manner to the satisfaction of the Contract Manager.

7. PROCUREMENT FROM OTHER SUPPLIERS

The Municipality may procure plant in terms of this contract, from another supplier. This Contract therefore does not bind the Municipality to procure plant from adjudicated bidder / supplier.

8. DRIVER/OPERATORS

Contractor /Supplier must ensure that operators/drivers is in possession of a valid certificate for operating the plant.

9. GENERAL CONDITIONS
