1. INTRODUCTION AND PURPOSE

The appointment is to acquire the services of a contractor to conduct repair work of the Bon Accord Quarry Crusher and Asphalts Plant in the City of Tshwane.

2. BACKGROUND

The City of Tshwane has an asphalt plant in Bon Accord Quarry that experienced frequent breakdowns due to normal day-to-day production operations. The Asphalt Plant is used to manufacture Hot-mix Asphalt, which is supplied to the regional maintenance section to maintain their roads, repair and patch potholes. A well-functioning Asphalt Plant is critical in the maintenance of roads in the whole City of Tshwane.

The City of Tshwane also operates a Crusher Plant that produces road building materials and requires maintenance to keep the assets in a good state.

3. PROJECT SCOPE

The City of Tshwane requires the following services to be conducted by the appointed contractor:

- a) Supply, delivery and installation of Conveyor belts and conveyor rollers.
- b) Removal, repair and reinstallation of weighbridges.
- c) Repair and maintenance of aggregates chutes.
- d) Repair and maintenance of crusher plant control room.
- e) Repair and maintenance of pumps, motors, motor gearboxes.
- f) Repair and Maintenance of emission stack, boiler, extraction fan, cyclones.

SPECIFICATION:

- **ITEM 1:** Supply, delivery and installation of conveyor belts and conveyor rollers.

BELTUSED – 750 mm x 2nd hand belting; To supply 1 x 65m roll, Thickness 11 – 15 mm. SPLICE – Cold splice

BELTUSED – 600 mm x 2nd hand belting; To supply 1 x 35m roll, Thickness 14 mm. SPLICE – Cold splice

CONVEYOR ROLLERS – Overall shaft length 300 mm , roll diameter 152mm , wall thickness 6mm, shaft diameter 25mm, slot width 30mm, closed end.

- **ITEM 2:** Removal, repair and reinstallation of weighbridges and linked computer and printer systems

Supply of lighting protection units

Supply of load cells (HBM C16 / 30 ton)

Supply of load cells for trolley, bogey or compactor units

Supply of weighbridge display / indicator (DUX SL, DUX SS or DUX SG) inclusive of power supply

Supply of a traffic remote display inclusive of power supply

Supply of a 8 way Printed circuit board (PCB) for weighbridge inclusive of waterproof junction box / enclosure, glands, connectors, wiring, etc.

- **ITEM 3:** Repair and maintenance of aggregates chutes.

Repair aggregate chute on belt no 2 for gradual and sliding release of stones on onto belt no. 2

- **ITEM 4:** Repair and maintenance of crusher plant control room.

Professional welding and reinforcement with steel plates and other materials.

Remove rust from affected areas using suitable methods

Apply rust inhibiting primer and paint

Replace damaged and corroded panels.

Seal control room to prevent dust entering.

- **ITEM 5:** Repair and maintenance of pumps, motors, motor gearboxes.

Supply, deliver and install motor gearbox to 19mm stone conveyor belt.

Supply, deliver and install diesel pump.

Supply, deliver and install bitumen pump.

Supply, deliver and install extraction fan motor.

Supply, deliver and install water pump.

Supply, deliver and install mixing drum motor.

- **ITEM 6:** Repair and Maintenance of emission stack, boiler, extraction fan, cyclones.

Sand blast, remove rust and paint emission stack and cyclones.

Repair boiler diesel combustion system.

Repair and realign extraction fan.

Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.
