1. INTRODUCTION AND PURPOSE

The City of Tshwane invites quotations for the appointment of a single service provider for the supply, delivery, commissioning, and handover of fully fitted Thermal Drones or Equivalent Drone, inclusive of extended warranty, operator training, and certification, to the City of Tshwane:

2. BACKGROUND

The City Of Tshwane conducts law enforcement operations and emergency services search and rescue operations in accordance with its legislative mandate, which includes tactical deployments that require advanced aerial surveillance technologies.

The multi-sensor enterprise thermal drones are required to enhance operational capabilities in:

- Public safety monitoring
- Crime prevention and tactical response
- Search and rescue operations
- Crowd management and surveillance
- Disaster and emergency response

- Critical infrastructure monitoring and surveillance
- Evaluate the extend of fires and damage
- Arial assessments of the scenes and the extend of fires before starting rescue operations
- Provide rapid, real-time aerial footage for searching, mapping, and monitoring floods, fires, and infrastructure damage, particularly in inaccessible or dangerous areas.

The proposed system must be designed for high-performance enterprise use, incorporating thermal imaging, visual intelligence, and real-time data capabilities.

3. COMPLIANCE AND STANDARDS

The appointed service provider must comply with:

- All equipment shall be delivered in protective carry cases
- Drones must support day/night operations and adverse conditions
- The unit shall be extremely robust and hard-wearing
- Shall be able to withstand extreme heat, smoke and harsh weather
- The drone shall have hovered capability

- Have minimum flight time of 40 minutes (under standard conditions)
- Include RTK positioning capability for precision operations
- Support AI-assisted object detection and tracking
- Software shall be capable to execute Realtime 2D and 3D reconstruction and mission planning

4.3.2 Thermal and Imaging Capabilities

- Thermal resolution: Minimum 640 × 512 pixels
- Zoom capability: Hybrid optical/digital zoom
- Temperature measurement range suitable for operational environments
- Temperature requirements for emergency search and rescue operations shall be a minimum of 40°C
- Thermal temperature range shall be a minimum of -20°C to 550°C
- High frame rate thermal imaging

Should the city exercise this option, where a tenderer offers a price that is deemed not to be viable to supply goods or services as required, written confirmation will be made with the bidder if they will be able to deliver on the price, if a bidder confirm that they cannot, the bidder will be disqualified on the basis of being non-responsive. If they confirm that they can deliver, a tight contract to mitigate the risk of non-performance will be entered into with the service provider. Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a bidder scoring the highest points. CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
