Supply, install, configure, test and commission a complete Microsoft Teams Rooms (MTR) solution for a large boardroom.

The boardroom currently has a ceiling-mounted projector and projection screen which will remain in service. The successful bidder shall integrate the new Microsoft Teams Rooms solution with the existing display infrastructure.

The solution shall include all hardware, software, cabling, mounting accessories, licensing (where applicable), commissioning, user testing and end-user training required for a fully operational system.

2. Microsoft Teams Rooms Requirements

The solution shall:

- Be a certified Microsoft Teams Rooms solution.
- Support native Microsoft Teams meetings.

- Support one-touch join from the room console.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“The Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
