1. BACKGROUND

In line with the Disaster Management Act, 2002 (Act No. 57 of 2002), the Ugu District Disaster Management and Fire Services Centre is in the process of facilitating accredited fire and rescue training within the district.

The Ugu District Disaster Management and Fire Services Centre requires the services of an accredited training college, academy or suitably qualified service provider to undertake the processes outlined below.
