Provision of Accounting Services in respect of preparation of Debt Impairment Calculation as per GRAP 104 using Expected Credit Loss Model Tool for calculating such financial Instruments, including training and support

BACKGROUND

The Municipality requires the provision of accounting services to calculate debt impairment losses or provision for doubtful debts as per GRAP 104 Financial Instruments using Expected Credit Loss Model Tool/software, including support and training:

The Municipality generates revenue from:

- Property rates
- Service charges
- Government grants and transfers

Revenue is recognised in terms of:

- GRAP 9 – Revenue from Exchange Transactions
- GRAP 23 – Revenue from Non-Exchange Transactions

Receivables and financial instruments are accounted for in terms of:

- GRAP 104 – Financial Instruments (Revised)
- GRAP 108 – Statutory Receivables
- Other applicable GRAP standards

The revised GRAP 104, effective from the 2026 financial year, introduces a forward-looking Expected Credit Loss (ECL) model, which requires municipalities to incorporate:

- Historical data
- Current conditions
- Forward-looking macroeconomic information
- Time value of money

This represents a significant technical and operational shift requiring specialised expertise.

Preparation and calculation of debt impairment using GRAP 104 guidelines for 2025/2026 Annual Financial Statements and necessary comparative and accounting policy reviews.

The service provider is to provide a software tool that must enable the municipality to seamlessly import and integrate the trial balance from the accounting systems and be able to produce automated financial statements that are GRAP and MFMA compliant using data from the trial balance arising from the financial management system.

The service provider must be able to provide on-site support to the users, as and when required by the users of the accounting software tool.

SCOPE OF WORK

1. Preparation of Debt Impairment Methodology and Calculation for 2025-2026 AFS as per GRAP 104 (Revised) for Financial Instruments.

2. Supply/Development, customization, delivery, and implementation of an Expected Credit Loss (ECL) model in line with GRAP 104 (Revised) for Financial Instruments.

2.1 Supply / Development, customization, delivery, and implementation of the proposed impairment **Expected Credit Loss (ECL)** model for receivables in terms of GRAP 104 (revised). If a new model should be developed, it should ideally be Excel-based. The customization and implementation should include the modification of the model to input data from available reports from the SOLAR financial system, without the need for human intervention/manipulation of data into another format.

2.2 Annual License fee for the ECL model (if applicable)

Yearly use, updates, and maintenance of ECL Model.

2.3 Ad-hoc consulting/support fees

- Assistance with the updating of the Annual Financial Statements with revised accounting policies and disclosures as required by the revised GRAP 104 for Financial Instruments.
- General assessment and implementation of other changes required by the revised GRAP 104 (not covered above).
- Technical training/discussions on the implementation of the revised GRAP 104 (if and when applicable and required)
- Assistance with answering of audit queries (should there be any that arises) related to the implementation of the revised GRAP 104.
