## 1 PURPOSE

The purpose of this Request for Quotation (RFQ) is to appoint a service provider to Support the Design, Facilitation, and Documentation of the Inclusive Land Framework (ILF) through technical input and guidance and facilitated workshops in **Greater Kruger Mega Living Landscape within the Southern part (Barberton -Makhonjwa) and Greater Mapungubwe** as well a national workshop for key national stakeholders. The national workshop will target civic society and government/entities separately.

## 2 BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly. South African National Parks (SANParks), in line with its Vision 2040 and Mega Living Landscapes (MLL) approach, is undertaking a structured, multi-stakeholder process to co-create an **Inclusive Land Framework (ILF)**. The ILF seeks to enable voluntary, partnership-based land inclusion that strengthens land rights, enhances biodiversity outcomes, and unlocks socio-economic benefits for historically marginalised landholders.

Given the complexity, sensitivity, and strategic importance of land in South Africa, SANParks requires the services of a suitably qualified and independent service provider to support the **design, facilitation, and documentation** and revision of the Inclusive Land Framework for SANParks.

### **3 SCOPE OF WORK**

South African National Parks (SANParks) invites an experienced consultant to act as a technical and process partner to SANParks in the development of the Inclusive Land Framework, ensuring that the process is:

- Credible and inclusive
- Technically sound and legally informed
- Ethically facilitated (including appropriate local language use and cultural nuances)
- Implementation-ready and Board-ready

The appointed service provider will be required to support the following phases:

#### **3.1 Phase 1: Technical and Conceptual Consolidation**

- Co-design and facilitate targeted technical workshops which will consist of two local workshops to be held within the Greater Kruger Mega Living Landscape as well one that will accommodate national stakeholders.
- Prepare workshop briefing documents for discussion and translated into as least two local languages as relevant.
- Identify associated risks relating to social and environmental safeguards; ethical, financial; legal, institutional, and implementation aspects of the Inclusive Land Framework
- Develop a technical issues and responses paper/document format as well workshop outcomes.
- Refine Inclusive Land Framework for SANParks based on the stakeholder input and technical input from the service provider.

#### **3.2 Phase 2: Social Compact and Relationship-Building**

- Design and facilitate community–state–SANParks dialogues in appropriate local languages
- Support articulation of rights, commitments, and safeguards
- Document Social Compact elements and community expectations
- Document possible governance arrangements to effect successful implementation of Inclusive Land Framework.

### **3.3 Phase 3: Economic and Risk Dialogues**

- Facilitate thematic dialogues on inherent risks relating to financing mechanisms, benefit-sharing, social and environmental safeguards; ethical, legal, institutional, and implementation aspects of the Inclusive Land Framework
- Support development of a risk register and mitigation measures
- Document viable economic pathways/ land inclusion incentives

### **3.4 Phase 4: Consolidation and Reporting**

- Produce a comprehensive Stakeholder Input Report
- Support revision of the ILF for governance processes
- Ensure a clear audit trail between stakeholder input and final outputs accredited / issues and response report and the revised Inclusive Land Framework

- Detailed process and facilitation design, responsive to local context within which workshops are held
- Workshop discussion document as translated

## 5 RESPONSIBILITIES OF THE SERVICE PROVIDER

#### 5.1.1 Senior Process Lead / Lead Facilitator

**Purpose:** Overall design integrity, neutrality, and credibility of the process.

**Required competencies:**

- 15+ years' experience in **land reform, natural resource governance, or social compacts** in South Africa
- Proven track record facilitating **high-conflict, multi-stakeholder processes** (communities, state, traditional authorities, civic society etc)
- Deep understanding of:
  - South African Land Tenure System
  - Communal land tenure systems (CPAs, Trusts, Traditional Authorities)
  - Power asymmetry and rights-based facilitation
- Strong political acuity and ethical facilitation practice
- Independence and credibility with both state and community actors

#### 5.1.2 Participatory Process Designer

**Purpose:** Design of the phased engagement architecture and workshop methodologies.

**Required competencies:**

- Expertise in **participatory design**, co-creation, and deliberative dialogue
- Experience designing **phased, multi-stage and multilingual processes** (pre-workshops → main workshop → consolidation)
- Familiarity with:
  - Systems thinking
  - Voice, Choice, and Action (VCA) or similar frameworks
  - Social compacting methodologies
- **Ability to translate abstract policy objectives into practical engagement tools**

### 5.1.3 Land, Legal, and Governance Specialist

**Purpose:** Ensure technical and legal credibility of the ILF content.

**Required competencies:**

- Expertise in South African land and conservation legislation, including:
  - NEMPAA
  - Restitution of Land Rights Act
  - CPA Act and Trust Property Control Act
  - Spatial Planning and Land Use Management Act (SPLUMA)
  - Legal framework governing traditional leaders' role in land use and management
- Experience with:
  - Co-management agreements
  - Stewardship models
  - OECMs and contractual parks
- **Ability to identify legal “red flags”, risks, and reform implications. Policy drafting and legislative advisory experience preferred.**

### 5.1.4 Socio-Economic and Biodiversity Economy Specialist

**Purpose:** Ground the ILF in viable economic and benefit-sharing pathways.

**Required competencies:**

- Experience in:
  - Biodiversity economy initiatives
  - Community benefit-sharing models
  - Nature-based livelihoods (tourism, restoration, carbon, offsets)
- **Understanding of governance risks (elite capture, financial leakage)**
- **Ability to translate complex financial concepts into accessible formats for communities.**

### 5.1.5 Rapporteur and Technical Writer

**Purpose:** Institutional memory, audit trail, and Board-ready outputs.

**Required competencies:**

- Exceptional analytical writing and synthesis skills
- Experience producing:
  - Stakeholder Input Reports
  - Policy frameworks
  - Board and EXCO-level documents
- **Ability to:**
  - **Accurately capture divergent views**
  - **Distinguish consensus from contestation.**
  - **Maintain neutrality and traceability of inputs**
- **Familiarity with SANParks / public-sector governance standards advantageous**

### 5.1.6 Secretariat and Logistics Coordinator

**Purpose:** Operational integrity and stakeholder experience.

**Required competencies:**

- Coordination of complex, multi-stakeholder engagements
- Stakeholder communication and scheduling
- **Document control, version management, and follow-ups**
- **Ability to support SANParks without displacing institutional ownership**

### 5.1.7 Cross-Cutting Competencies (Mandatory)

All team members must demonstrate:

- Cultural competence and ethical sensitivity
- Experience working with **historically marginalised communities**
- Ability to operate in **politically sensitive environments**
- Commitment to co-creation (not extractive consultation) and quick turn-around feedbacks to workshop participants on their articulated inputs and next steps for this
- Strong facilitation ethics and confidentiality standards

## 6 RESPONSIBILITIES OF SANParks

SANParks is positioned as:

- **Convenor**, not sole author of the ILF
- **Custodian of process integrity**
- **Anchor institution for governance coherence**
- Provide a briefing to the successful provider to ensure they understand the context and anticipated outcomes.
- Provide all internal documents where necessary.
- Provide workshop logistics with respect to venues, accommodation and travel and catering for the stakeholders.
- Overall Management of the project.
- Communicate and liaise with critical stakeholders regarding the process and outputs (including media)

The rights and obligations set out in this clause shall service termination of this contract indefinitely.

### **Confidentiality**

The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not:

- (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent.
- (b) Use, exploit or in any other manner whatsoever apply the confidential information for any other purpose whatsoever, other than for the execution of the contract and the delivery of the deliverables or
- (c) Copy, reproduce, or otherwise publish confidentiality information except as strictly required for the execution of the contract.

The recipient shall ensure that any employees, agents, directors, contractors, service providers, and associates which may gain access to the confidential information are bound by agreement with the recipient both during the term of their associations with the recipient and after termination of their respective

associations with the recipient, not to

- (a) Disclose the confidential information to any third party, or
- (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
