2 BACKGROUND

SABC Limited is a public organization and State-Owned Entity (SOE). It is a national broadcaster and delivers via four television channels as well as eighteen radio stations. The SABC head office is based in Auckland Park, Johannesburg, with provincial offices in South Africa. SABC is looking for a service provider that will monitor, verify and report on sponsorship elements broadcast across SABC television channels, enabling the SABC to confirm campaign delivery, support revenue recognition and provide clients with evidence of performance.

Sponsorship tracking is a critical control in the execution and reporting of television sponsorship campaigns. It enables the SABC to reconcile classic advertisements and secondary sponsorship elements that were broadcast, including squeeze backs, crawlers, logo placements, stings and presenter mentions. The resulting reports and video evidence support campaign fulfilment reporting, client engagement, revenue recognition and revenue assurance.

3 REQUIREMENTS AND SCOPE OF SERVICES

- **Monitoring and Verification**

Monitor, record and report on all sponsorship elements broadcast across SABC television channels, including classic advertisements and secondary elements such as squeeze backs, crawlers, logo placements, stings and presenter mentions.

- **Campaign Fulfilment Reporting**

Provide accurate reporting that enables the SABC to reconcile booked sponsorship elements against actual broadcasts and confirm whether campaigns were delivered in accordance with client instructions.

- **Creative Verification Reports and TAMS integration**

Provide creative verification reports in the file layout required by the SABC. Standard reports must be delivered weekly in Excel format, with daily reporting available when required for special events or priority campaigns.

- **Proof of Broadcast**

Provide weekly video clips as proof of broadcast for all monitored sponsorship elements, with the ability to retrieve evidence promptly for client queries and campaign reconciliation.

- **Ratings and Audience Integration**

Integrate sponsorship-element data with television audience measurement data and analytical tools, where required, to enable assessment of audience delivery and relevant demographic segments.

- **Data Delivery and Reporting**

Deliver complete, accurate and timely data in agreed electronic formats and provide dashboards or analysis tools that support campaign tracking, exception management and management reporting.

- **Implementation and Service Continuity**

Provide a clearly defined transition and implementation plan that enables the replacement service to commence on 1 January 2027 and minimises the risk of any interruption in monitoring or reporting.

- **Technical Support and Account Management**

Provide onboarding, user training, ongoing technical support, service-level reporting and dedicated account management throughout the contract period.

The successful bidder will be required to demonstrate appropriate monitoring coverage, reliable technology, data-quality controls, secure retention of evidence, sufficient operational capacity and relevant experience in sponsorship or broadcast monitoring.

10.1 PRICE

10.3 ADJUDICATION USING A POINT SYSTEM

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

10.4 Objective Criteria

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within **12 months** after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 12 (**Twelve**) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of **5 (Five)** years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of **12 (Twelve)** months has expired.
- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

11 COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

12 CONDITIONS TO BE OBSERVED WHEN TENDERING

- The corporation does not bid itself to accepts the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or

more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.
- **The Corporation reserves the right to:**
 - Make a selection solely on the information received in the submissions
 - Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
 - Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
 - Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

13 Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

14 PAYMENT TERMS

SABC will effect payment sixty (60) days after the service provider has rendered the service and submitted an invoice / statement.

1. CONSORTIUMS AND JOINT VENTURES
