SAMSA have adopted the usage of advanced technologies as a strategic enabler to deliver on its strategic objectives. As such, the UPS forms part of the critical ICT hardware components that form part of the total ICT environment.

SAMSA REQUIREMENTS

The UPS equipment's services include but are not limited to the following activities:

The service inspection/health check shall include:

- Voltage parameter tests
- Charger and inverter tests
- Battery float tests
- Battery runtime tests
- Cleaning of UPS
- Blowing out all dust build up in UPS
- Execution and maintenance of the UPS Service Plan.
