- A submission submitted in response to this RFQ will constitute a binding offer which will remain binding and irrevocable for a period of **thirty (30) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFQ validity period is still in force. **(RFQ Validity Period: 30 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFQ.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.
- There shall be no discussions with any enterprise until evaluation of the proposal has been complete.
- RFQ's received after closing time and date will be classified as **LATE** and will not be considered.
- With regards to pricing, where a bidder submits both a quote and SBD 3, should the total bid prices differ, or calculation errors be identified, the one indicated on the SBD 3 pricing schedule shall be considered the correct price.

TERMS OF REFERENCE/SCOPE OF WORK

1.1 OVERVIEW

The Mine Health and Safety Council is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended.

The entity comprises a tripartite board represented by State, Employer, and Labour members under chairmanship of the Chief Inspector of Mines. The MHSC is funded by public revenue and is accountable to Parliament.

The main task of the Council is to advise the Minister of Mineral Resources on occupational health and safety legislation and research outcomes focused on improving and promoting occupational health and safety in South African mines. The Council also oversees the activities of its committees; promotes a culture of health and safety in the mining industry; arranges a summit every two years to review the state of occupational health and safety at mines; and liaises with the Mining Qualifications Authority and any other statutory bodies about mining health and safety.

1.2 DETAILED SPECIFICATIONS/SCOPE OF WORK

The MHSC invites service providers to submit proposals for the delivery of the following scope of work, using the MHSC's existing Microsoft O365 E5 and Windows Server 2025 licences (unless additional licences are specifically required and quoted):

- **Active Directory Reinstallation:** Reinstall Microsoft Active Directory Domain Services (AD DS) on MHSC's Windows Server 2025 infrastructure.
- **Azure AD Synchronisation:** Configure Microsoft Entra Connect to synchronise on-premises AD with the existing Microsoft 365 / Azure AD tenant.
- **On-Premises Server Remediation (if required):** Troubleshoot, patch, and remediate on-premises servers to ensure a stable AD environment.

- 
- **Technical Handover & Documentation:** Provide as-built documentation and a handover session for the MHSC ICT team.
 - **Project Management:** Deliver a Project Plan, Risk Register, status reports, and a final Closeout Report.

The service provider shall implement the following solution for the MHSC:

1.2.1 Active Directory Reinstallation

- Assess the current Active Directory environment (if any) and recommend a clean installation or authoritative restore.
- Install and configure Active Directory Domain Services (AD DS) on MHSC's existing Windows Server 2025 licences (servers to be provided by MHSC).
- Configure DNS, Group Policy Objects (GPOs), and organisational units (OUs) in line with MHSC's security and operational requirements.
- Create or restore user, group, and computer objects as needed, ensuring no data loss.
- Validate the health and functionality of the new AD DS environment.

1.2.2 Azure AD Synchronisation (Entra Connect)

- Install and configure Microsoft Entra Connect (latest version) on a designated server.
- Synchronise on-premises AD with MHSC's existing Microsoft 365 / Azure AD tenant (using existing O365 E5 licences, which include Entra ID P2).
- Enable password hash synchronisation or pass-through authentication (to be agreed with MHSC).
- Configure Seamless Single Sign-On (SSO) for hybrid joined devices.
- Test and validate synchronisation, including identity matching, attribute flow, and sync cycles.
- Provide a rollback plan in case of critical errors during the reinstallation or sync configuration.

1.2.3 On-Premises Server Remediation (as needed)

- Conduct necessary troubleshooting, patching, and remediation activities on identified on-premises servers to ensure they are in a suitable state for a stable AD environment and successful synchronisation.



1.2.4 Technical Handover & Documentation

- Provide comprehensive as-built documentation, including AD topology, GPO settings, OU structure, and Entra Connect configuration.
- Conduct a technical handover session (minimum 2 hours) for the MHSC ICT team.

1.2.5 Project Management

- Deliver a Project Charter, detailed Project Plan, Risk Register, Communication Plan, weekly status reports, and a final Project Closeout Report with lessons learned.

1.3 CONTRACT PERIOD

The contract will be valid for a once period.

Specific goals

Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:

- (i) **Price** - with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.
- (ii) **Preference** - preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.

A maximum of 80 points will be allocated for price on the following basis:
