### ***T1.1 Tender Notice and Invitation to Tender***

The Eastern Cape Department Public Works and Infrastructure invites Professional Service Providers for the **PROVISION OF PROFESSIONAL ARCHITECTURAL SERVICES AND PRINCIPAL AGENCY FOR THE CONSTRUCTION OF NEWLANDS CLINIC**. The contract will be based on the **CIDB Professional Services Contract (Third edition) 2009**.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit tenders.

Bid documents are downloadable free of charge from the Eastern Cape Department of Public Works and Infrastructure website ([www.ecdpw.gov.za/tenders](http://www.ecdpw.gov.za/tenders)). Bid documents will be available on **18 May 2026**. No bid documents will be available at departmental offices.

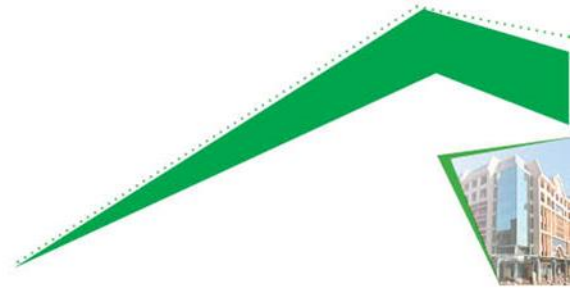
The closing time for receipt of tenders by the ECDPWI is 11:00am on the **18 June 2026**. Tender will be open in public.

Bids must be submitted in sealed envelopes clearly marked “**SCMU5-26/27-0016 AMR INF PROVISION OF PROFESSIONAL ARCHITECTURAL SERVICES AND PRINCIPAL AGENCY FOR THE CONSTRUCTION OF NEWLANDS CLINIC** and must be deposited in the tender box, **located at: DEPARTMENT OF PUBLIC WORKS AND INFRASTRUCTURE, BLOCK B BUILDING, RECEPTION AREA, CNR of SCHOLL RD & AMALINDA MAIN ROAD, AMALINDA, EAST LONDON**.

It is the responsibility of the bidder/s to ensure that bid documents /proposals are submitted on or before closing time and at the correct location as the department will not take responsibility for wrong delivery. Bidders using courier services for delivery of their bid documents must ensure the delivery is at the correct place / location and time as the department will not be held responsible for wrong delivery. Bid documents must only be deposited in the tender box and not be handed over to any departmental official. The department will not accept responsibility if bids are handed to department officials and are not timeously deposited in the tender box.

Tenders may only be submitted on the tender documentation that is issued. Tenderers must be registered on the National Treasury Central Supplier Data Base and proof of registration must be submitted with the proposal (<https://secure.csd.gov.za>).

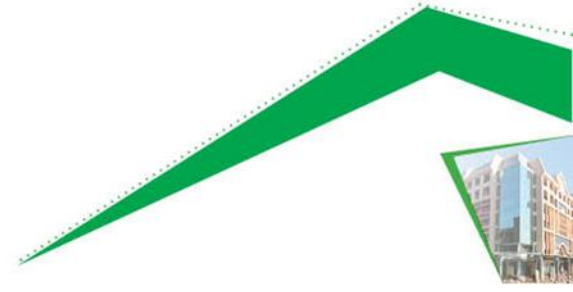

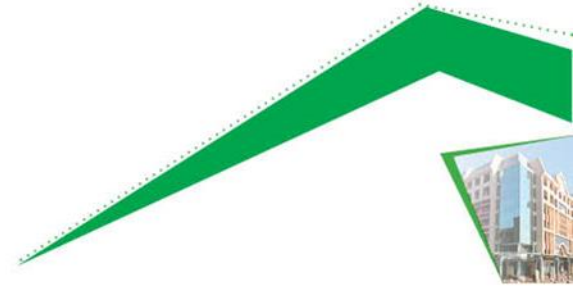
## T1.2 Tender Data

5.1	The Employer will respond to requests for clarification received up to <b>Seven (7) working days</b> before the tender closing time. If, as a result of the issuing of addenda, it is necessary to extend the closing time stated in the tender data, grant such extension and notify all respondents accordingly.												
5.2	The employer shall issue addenda until <b>Seven (7) working days</b> before tender closing time.												
5.3	Tenders will be opened immediately after the closing time for tenders at <b>11:00am</b> .												
5.4	Do not disclose to tenderers, or to any person not officially concerned with such processes, information relating to the evaluation and comparison of tender offers, the final evaluation price and recommendations for the award of a contract, until after the award of the contract to the successful tenderer.

- 2.2 The Department will contract with the successful bidder by signing a formal contract.
- 2.3 All items listed in the Pricing schedule must be priced for (except provisional sums and allowances which must also be added to the total), failure to do so will increase commercial risk of the bid and may lead to elimination or passing over of the bidder.
- 2.4 The bidder has duly completed and signed the SBD 1, and SBD 6.1.
- 2.5 Bidders need to complete and sign SBD 6.1 to claim points for specific goals. Failure to complete will lead in non-awarding of points for specific goals.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

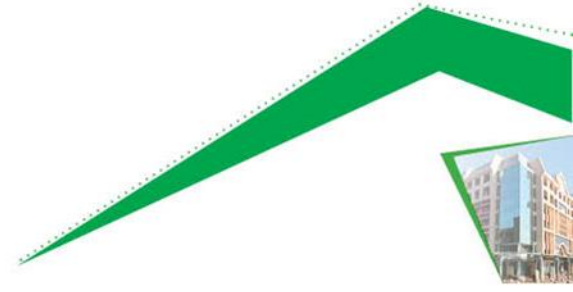
The introduction of The Protection of Personal Information Act (POPIA) ensures the regulation of personal information through its entire life cycle of collection, transfer, storing and deletion. ## PART C2.1: Pricing Instructions

Pricing Instructions mean the criteria as set out below, read together with all Parts of the contract document, which it will be deemed in the contract that the Tenderer has taken into account when developing his prices.

1. The short descriptions given in the Pricing Schedule below are brief descriptions used to identify the activities for which prices are required. Detailed descriptions of the activities to be priced are provided in the Scope of Work, with reference to **Government Gazette No. 51352 dated 4<sup>th</sup> October 2024** for persons registered in terms of the South African Council for the Architectural Profession (SACAP), where applicable.
2. While it is entirely at the Tenderer's discretion as regards pricing the Activity Schedule below, the Guideline Professional Fees in terms of the **Guideline Professional Fees in terms of Section 34 (2) of the Architectural Profession Act, 2000 Act 44 of 2000, Board Notice 672 of 2024–Government Gazette No. 51352 dated 4<sup>th</sup> October 2024**, respectively are useful documents that will give Tenderers some idea of industry norms against which they may compare their rates, sums, percentage fees and/or prices as applicable.
3. The rates, sums, percentage fees (as applicable) used by a Tenderer to determine his offer shall not exceed the rates stipulated by the Guideline Scope of Services and Tariff of Fees for Persons Registered in terms of the South African Council for the Architectural Profession (SACAP) and Department of Public Works: Rates for Reimbursable Expenses document, respectively.
4. For the purpose of the Activity Schedule, the following words shall have the meanings hereby assigned to them:
  - Unit: The unit of measurement for each item of work.
  - Quantity: The number of units of work for each item.
  - Rate: The agreed payment per unit of measurement.
  - Amount: The product of the quantity and the agreed rate for an item.
  - Sum: An agreed lump sum payment amount for an item, the extent of which is described in the Scope of Work, but the quantity of work which is not measured in any units.

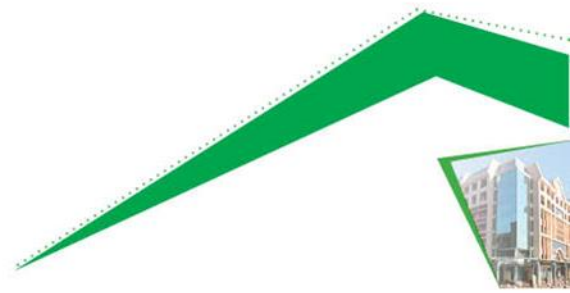


7. Where quantities are given in the Pricing Schedule, these are provisional and do not necessarily represent the actual amount of work to be done. The quantities of work accepted and certified for payment will be used for determining payments due and not the quantities given in the Activity Schedule. 13. All charges in respect of attendance at meetings and the provision of secretarial services shall be deemed to be included in the tendered basic fee for normal services (Item No.1 of the Activity Schedule).
14. While the Employer has every intention to complete the full scope of works, the Employer reserves the right to reduce or increase the scope of works according to the dictates of the budget, or to





terminate this contract, without adjustment to the agreed rates, sums or fees and without payment of any penalty or surcharge in this regard. The Service Provider shall however be entitled to pro-rata payment for all services carried out in terms of any adjustment to the Scope of Work or, in the case of termination, remuneration and/or reimbursement as described in Clause 8.4.4 of the Standard Professional Services Contract.
